### RESTRICTIONS AND EXCLUSIONS

1. Vacation or Special Watches for any residence will be for a maximum (14) consecutive days, or as directed by Constable Brown. Constable Brown can suspend or cancel any watch without cause.
2. Please notify the Pct. 1 Constables Office if you return on or before the expiration date or if ANY of the above items change.
3. Precinct 1 Constables Office or its Deputies cannot guarantee a specific time or date your residence will be checked, but will ever effort to check on your residence as time and workloads allow.  
The residential check will consist of a street view inspection, unless something is observed that would cause the need to initiate more thorough inspection.
5. During the time of natural or man-made disasters, storms, floods, riots, etc., all vacation watches will be suspended.
6. Do not change your alarm system notification to the Pct. 1 Constables Office.
7. If at any time you have a police, fire or ambulance / EMS emergency, make sure you call 911 for service, NOT Precinct. 1.
